As we have completed the SAFER Guides over the last 3 years, we have been mostly positive with our compliance with the recommendations; however, our review in 2024 was more critical and some statuses changed to partially implemented or not implemented (downgraded) because we realized that we had processes in place to close a recommendation gap that the EMR did not address. We felt this was the only way we could push our EMR vendor to addresses these gaps.
