The Children with Chronic Conditions (CCC) supplemental item set provides information on parents' experiences with their child's health care for the population of children with chronic conditions. States or health plans that include the CCC supplemental items draw a sample of children in the general population as well as a supplemental sample of children identified through a claims-based algorithm as being likely to have a chronic condition. The survey instrument includes a screener to identify children with a chronic condition. The CCC population includes all children identified as having a chronic condition, based on the responses to the CCC survey-based screening tool.

This table shows results for the general child (GC) population, which includes children originally selected for the GC sample and children originally selected for the CCC supplemental sample who did not meet the CCC survey-based screening criteria. Rates for the CCC population are not reported for 2023 Core Set reporting because they were reported by fewer than 25 states.

The term "states" includes the 50 states, the District of Columbia, and Puerto Rico.

States are not asked to report CAHPS data to CMS in the Quality Measure Reporting (QMR) system. Instead, states submit their CAHPS data to the AHRQ CAHPS Health Plan Survey Database and submissions for each state are combined into state-level results for Child Core Set reporting. More information about the AHRQ CAHPS Health Plan Survey Database is available at https://cahpsdatabase.ahrq.gov/HPSurveyGuidance.aspx. To be included in state-level reporting, submitters were required to sign a data use agreement (DUA) authorizing AHRQ to share the data with CMS for Core Set reporting. AHRQ and CMS calculated state-level performance based on the data submissions authorized for use in Child Core Set reporting. State-level results were adjusted for the case mix of beneficiaries responding to the survey and were weighted to create state-level results based on the relative enrollment size of each submission. The following state conducted CAHPS for Child Medicaid and CHIP beneficiaries and submitted data to the AHRQ CAHPS Database for the 2023 reporting period but did not authorize use for Core Set reporting: FL. The following states conducted CAHPS for CHIP beneficiaries but are not included in the table due to small denominators: AK, DE, and WI.

Denominators are the number of beneficiaries that responded to each survey question.

The state means are calculated as the unweighted average of all state rates. When a state reported separate rates for its Medicaid and CHIP populations, the state mean and state median rates are calculated using the rate for the program with the larger measure-eligible population.
